[Interview begins with impertinent questioning for ~7 minutes]

1. **Reporter:** Mr. President, you said yesterday you're falling out with Jeffrey Epstein was over him taking some of the workers from your business, but your administration in the past said that you threw him out because he was a creep. So can you explain that discrepancy?

8. **Reporter:** Mr. President, Epstein has a certain reputation, obviously. Just curious, were some of the workers that were taken from you, were some of them young women?
9. **Trump:** Were some of them...?
10. **Reporter:** Were some of them young women?
11. **Trump:** Uh, well, I don't want to say, but, uh, everyone knows the people that were taken and, uh, it was the concept of taking people that worked for me is bad. But, uh, that story's been pretty well out there. And the answer is yes. They were.
12. **Trump:** Yes. Yeah.
13. **Reporter:** What did they do?
14. **Trump:** in the spa.
15. **Reporter:** What was their jobs? In the spa?
16. **Trump:** Yeah. People that work in the spa, I have a great spa, one of the best spas in the world at Marla, and people were taken out of the spa. Hired by him, in other words, gone. And uh, other people would come and complain, this guy is taking people from the spa. I didn't know that. And then when I heard about it, I told him, I said, listen, we don't want you taking our people, whether it was spa or not spa. I don't want him taking people. And he was fine. And then not too long after that, he did it again. And I said, outta here, Mr. President
17. **Reporter:** Mr President, did one of those stolen, um, you know, persons, did that include Virginia Giuffre?
18. **Trump:** Uh, I don't know...I think she worked at the spa. I think so. I think that was one of the people. Yeah, he, he stole her. And by the way, she had no complaints about us, as you know, none whatsoever.
