**NOTICE OF SERVICE
EFFECTUATION**

I. Summary of Service

1. Plaintiff Joseph Kirchner, proceeding pro se, respectfully submits this Notice to inform the Court that service of process has been completed upon nine of ten named Defendants in compliance with the Court's Minute Order dated February 12, 2026, and well in advance of the April 20, 2026 deadline. Service upon Defendant Donald J. Trump remains pending due to delivery issues at the White House, and Plaintiff is simultaneously filing a Motion for Alternative Service.

2. Plaintiff has served nine of ten named Defendants via USPS Certified Mail. The first service on February 26, 2026 was mailed with assistance from Elijah Steeber. To ensure full compliance with the Court's requirements regarding confirmation of receipt, Plaintiff re-served all nine successfully served Defendants on March 10, 2026 with Return Receipt Requested; this second service was mailed with assistance from Shevaun Church.

3. Delivery of both rounds of service has been confirmed by USPS tracking for all Defendants except President Trump. Signed return receipts will be filed as a supplement upon receipt from USPS.

4. Service upon Defendant Donald J. Trump remains pending due to unusual delivery issues at the White House, as detailed below.

II. SERVICE ON THE UNITED STATES (GOVERNMENT DEFENDANTS)

A. First Service - February 26, 2026

5. Pursuant to Fed. R. Civ. P. 4(i)(1)(A)(ii), Plaintiff sent a copy of the summons and complaint for all five government Defendants to the Civil Process Clerk at the U.S. Attorney's Office for the District of Columbia via USPS Certified Mail (Tracking Number: 9589 0710 5270 2952 1967 60). Delivery was confirmed on March 3, 2026.

6. Pursuant to Fed. R. Civ. P. 4(i)(1)(B), Plaintiff sent a copy of the summons and complaint for all five government Defendants to the Attorney General of the United States via USPS Certified Mail (Tracking Number: 9589 0710 5270 2952 1967 08). Delivery was confirmed on March 3, 2026.

7. Pursuant to Fed. R. Civ. P. 4(i)(2), Plaintiff sent copies of the summons and complaint by certified mail to each government officer and entity:

B. Second Service - March 10, 2026 (With Return Receipt Requested)

9. To ensure full compliance with the Court's February 12, 2026 Minute Order regarding confirmation of receipt by an authorized person, Plaintiff re-served all government Defendants on March 10, 2026 via USPS Certified Mail with Return Receipt Requested.

1 **11.** Certified mail receipts and tracking confirmations for all service are attached
2 as Exhibit 2. Signed return receipts (PS Form 3811) will be filed as a supplement upon
3 receipt from USPS.

4 **12.** Plaintiff notes that while return receipt service (PS Form 3811) was requested
5 for the first service on February 26, 2026, the USPS clerk did not attach the green card
6 return receipt forms to the certified mail at the time of mailing. To ensure full
7 compliance with the Court's requirements, Plaintiff re-served all nine successfully
8 served Defendants on March 10, 2026 with Return Receipt Requested, and the green
9 card return receipt forms were properly attached to each mailing.

III. SERVICE ON PRESIDENT TRUMP

A. First Attempt - White House (February 26, 2026)

13. Plaintiff sent the summons and complaint to President Trump at The White House, 1600 Pennsylvania Avenue NW, Washington, DC 20500 (Tracking Number: 9589 0710 5270 2952 1967 84).

14. USPS tracking indicates a delivery attempt was made on March 3, 2026, at 12:16 PM, but was unsuccessful because "the business was closed." USPS indicated redelivery was scheduled for the next business day.

15. As of March 16, 2026, the mailing has neither been delivered nor returned to Plaintiff. It has remained in an unusual state of limbo at USPS facilities for thirteen days following the initial delivery attempt and is likely en route back to Plaintiff.

B. Second Attempt - White House Counsel's Office (March 9, 2026)

16. On March 9, 2026, Plaintiff sent a second mailing to the White House Counsel's Office at 1600 Pennsylvania Avenue NW, Washington, DC 20500 via USPS Certified Mail with Return Receipt Requested (Tracking Number: 9589 0710 5270 3072 2192 30).

17. As of March 16, 2026, this mailing also remains undelivered and is likely en route back to Plaintiff.

C. Third Attempt - White House (March 10, 2026)

18. On March 10, 2026, Plaintiff sent a third mailing to President Trump at The White House, 1600 Pennsylvania Avenue NW, Washington, DC 20500 via USPS Certified Mail with Return Receipt Requested (Tracking Number: 9589 0710 5270 1986 7708 61).

19. As of March 16, 2026, this mailing also remains undelivered and is likely en route back to Plaintiff.

20. The certified mail receipts and tracking history for all Trump mailings are included in Exhibit 2. Screenshots documenting the failed delivery attempts are included on pages 14, 15, and 30 of Exhibit 2.

D. Service on the United States is Complete

21. Regardless of the status of direct service upon President Trump at the White House, service upon the United States has been completed through both the Civil Process Clerk at the U.S. Attorney's Office pursuant to Fed. R. Civ. P. 4(i)(1)(A)(ii) and the Attorney General pursuant to Fed. R. Civ. P. 4(i)(1)(B).

22. The Department of Justice represents the President in his official capacity and is on notice of this litigation. The purpose of service—providing notice and an opportunity to defend—has been achieved.

23. Plaintiff is simultaneously filing a Motion for Alternative Service addressing the unusual circumstances surrounding service upon President Trump at the White House.

IV. SERVICE ON CORPORATE DEFENDANTS

A. First Service - February 26, 2026

24. On February 26, 2026, Plaintiff served all corporate Defendants via USPS Certified Mail at their registered agent addresses. Delivery has been confirmed by USPS tracking:

V. Clarification Regarding Prior Filings

28. Plaintiff acknowledges that Documents 14, 15, 16, and 17, filed January 19-20, 2026, contained certifications of service signed before Defendants had been served. These certifications were signed in error while filing under conditions of exhaustion. Plaintiff understands that certifications must reflect completed service and commits to ensuring accuracy in future filings.

29. Plaintiff further notes that Document 22 (AO 440 Summons forms) contains blank fields, including "District of Columbia," due to software incompatibility when completing the forms. Plaintiff will use compatible software for all future court forms.

30. Plaintiff respectfully requests that the Court accept this Notice and the attached documentation as proof of service upon the nine Defendants successfully served, and as documentation of good-faith efforts to serve Defendant Donald J. Trump.
