1. **Mosab Yousef (Israeli Agent):** But the entire Iranian regime is going to be history. The Iranian nuclear program is going to be destroyed, and anyone who gets in the way, it doesn't matter where they are, even if they are politicians in the west, they are going to fall because we cannot afford. Letting any Islamic entity, and I said this previously, and I mean, what I say, and you need to take this very seriously.
1. **Reporter Cenk Uyger:** Piers's, did you hold on, did you hear what he just said? He threatened politicians in the west that if they don't agree with Israel's war against Iran, that they're going to fall. And remember he's an Israeli agent. Are you saying Israel will murder politicians in the west or get rid of them politically through bribery or whatever else?
1. **Reporter Cenk Uyger:** What? What do you mean the politicians in the west will fall if they don't agree that to back Israel's war against Iran?
1. **Mosab Yousef (Israeli Agent):** Yeah. We will not vote for them anymore.
1. **Reporter Cenk Uyger:** Oh, well you don't vote for them now. You're not in our country.
1. **Reporter Cenk Uyger:** What do you mean the politicians will fall?
1. **Mosab Yousef (Israeli Agent):** We live in democracy and we have the right to bring them up and to bring them down. Those who agree with [indecipherable], we don't want them in office. All the sympathizers with terrorists such as yourself We don't want them here in our in country.
1. **Reporter Cenk Uyger:** Who is we and how are you bringing down [repeated three times during Yousef's prior statement]
1. **Reporter Cenk Uyger:** Who is we and how are you bringing down politicians in the west if they dare to defy Israel?
1. **Reporter Cenk Uyger:** Tell me how you're bringing them down.
1. **Mosab Yousef (Israeli Agent):** I already answered you that.
1. **Reporter Cenk Uyger:** Are you gonna murder them or are you gonna bribe them? Are you gonna bribe someone else? Who are you gonna do? And the, okay, so let me ask.

1. **Vice President Vance:** Uh, I'll take some questions, but I wanna just one final observation here. Uh, when I was actually walking out here, um, somebody sent me a photo of a CNN headline about what happened in Minneapolis, and this is the headline. I'm just gonna read it. Outrage after ICE officer kills US citizen in Minneapolis.
 2. **Vice President Vance:** Well, that's one way to put it. And that is the way that many people in the corporate media have put this attack over the last 24 hours. And I say attack very, very intentionally because this was an attack on federal law enforcement. This was an attack on law and order. This was an attack on the American people.
 3. **Vice President Vance:** The way that the media. By and large has reported this story has been an absolute disgrace and it puts our law enforcement officers at risk every single day. What that headline leaves out is the fact that that very off ice officer nearly had his life ended dragged by a car. Six months ago, 33 stitches in his leg.
 4. **Vice President Vance:** So you think maybe he's a little bit sensitive about somebody ramming him with an automobile. What that headline leaves out is that that woman was there to interfere with a legitimate law enforcement operation in the United States of America. What that headline leaves out is that that woman. Has as part of a broader left wing network to attack, to dox, to assault, and to make it impossible for our ICE officers to do their job.
 5. **Vice President Vance:** If the media wants to tell the truth, they ought to tell the truth that a group of left wing radicals have been working tirelessly, sometimes using domestic terror techniques to try to make it impossible for the president of the United States to do what the American people elected him to do, which is enforce our immigration laws.
 6. **Vice President Vance:** The president stands with ice. I stand with ice. We stand with all of our law enforcement officers and part of that is recognizing that you, people in the media, not everybody in this room, but many people in this room have been lying about this attack. She was trying to ram this guy with his, with her car.
 7. **Vice President Vance:** He shot back, he defended himself. He's already been seriously wounded in law enforcement operations before, and everybody who's been repeating the lie that this is some innocent woman who was out for a drive in Minneapolis when a law enforcement officer shot at her. You should be ashamed of yourself.
 8. **Vice President Vance:** Every single one of you questions.
 9. **Reporter:** Thank you, Mr. Vice President. I wanted to read a quote from Tim Walz earlier today. He said, when things looked bleak, it was Minnesota's first that held the line for the nation on July 3rd, 1863, and I think we may be in that moment

1 now. Can you comment on his rhetoric and Mayor Jacob Frey and whether they
2 want to see unrest in Minneapolis?

3 10. **Vice President Vance:** Well, it's very tough rhetoric from a guy who just quit
4 because his fraudulent activities have been uncovered. Look, Tim Walz is a joke.
5 His entire administration has been a joke. The idea. That he's some sort of freedom
6 fighter. He is not. He's the guy who has enabled fraud and maybe in fact has
7 participated in fraud.

8 11. **Vice President Vance:** That's what this new assistant attorney general position is
9 gonna find out. I don't care what Tim Waltz says. I care about getting to the bottom
10 of this fraud for the American people, and I care about enforcing the nation's
11 immigration laws. That's what we're gonna stay focused on.

12 12. **Reporter:** Our related question here, I mean, Democrats have accused ICE of
13 murder. They've said they're targeting Americans. Uh, they told ICE to get the F
14 out, uh, of Minnesota. This is going to stoke the fire against ICE agents. And you're
15 talking about ICE agents right now, being concerned about them. What, if
16 anything, is the administration going to do to make sure these folks are protected
17 during these protests, but also should DHS sort of revisit their procedures here?

18 13. **Reporter:** [continued] I mean, nobody wants to see an American killed. Uh, are
19 there changes that need to be made to make sure something like this doesn't happen
20 again?

21 14. **Vice President Vance:** Look, first of all, of course, nobody wants an American
22 citizen to be killed. This is absolutely a tragedy, but it's a tragedy of the making of
23 the far left. They have radicalized a very small segment of the population, taught
24 them that ice agents are engaging in wide scale violation of people's rights.

25 15. **Vice President Vance:** What our ICE officers are doing. Is deporting the millions
26 of criminal aliens that were let in during the Biden administration. So number one,
27 we have to say as a matter of leadership, and I would appreciate if the Democrats
28 would join me on this, let's be honest about the fact that we have way too many
29 illegal aliens in this country.

30 16. **Vice President Vance:** Our ice officers should be supported in doing their job.
31 You're trying to actually marshal the far left lunatic fringe to engage in. Doxing to
32 try to make it impossible for them to enforce the law, and in some cases actually to
33 engage in acts of domestic terrorism against our law enforcement officers.

34 17. **Vice President Vance:** Uh, when you talk about different plans, different
35 protocols, different policies, I, I, I forget exactly how you asked the question.
36 Here's the simple fact. What we're going to do is make it easier for the American
37 People's Administration to enforce the American people's law, and that means that
38 Democrats have to stop rallying the mob against legitimate law enforcement
39 operations, and that means that we are gonna get tougher. And that's what this
40 A.A.G. position is about. We're gonna get tougher at the people who are defrauding
41 the United States by, in inciting violence against our law enforcement officers.
42 That's one of the things that we're gonna do. We've already started that work at the
43 Department of Justice, but we're gonna keep on doing it.

- 1 18. **Vice President Vance:** And this new A.A.G. position is gonna kick that into high
2 gear.
- 3 19. **Reporter:** Vice President Vance, you just suggested that this woman who was
4 killed, Renee Goode, is part of a, a broader left wing network. Who do you think is
5 behind this broader left wing network?
- 6 20. **Vice President Vance:** Well, it's one of the things we're gonna have to figure out,
7 but here, here's the way that I put it. When somebody throws a brick at an ice agent
8 or somebody tries to run over an ice agent. Who paid for the brick and who told
9 protestors to show up and engage in violent activity against our law enforcement
10 officers. You see, just with this most recent terrible incident in Minneapolis, you
11 see friends of this woman's or other people who are eyewitnesses saying basically
12 that she was there to engage in obstruction of a legitimate law enforcement
13 operation.
- 14 21. **Vice President Vance:** How did she get there? How did she learn about this?
15 There's an entire network, and frankly, some of the media are participating in it that
16 is trying to incite violence against our law enforcement officers. It's ridiculous. It's
17 preposterous, and part of our investigatory work is getting to the bottom of it.
- 18 22. **Vice President Vance:** Who's funding it? Who's supporting it, who's cheerleading
19 it, and of course if there's illegal activity related to that, we're gonna get to the
20 bottom of that and prosecute it where we can.
- 21 23. **Reporter:** Vice president, thank you for taking questions today. Is there a risk
22 with you describing her as a deranged leftist, talking about very specific facts of
23 these events when an investigation is just beginning? Are you preempting a
24 thorough investigation by drawing such conclusions? And have you received any
25 information beyond the videos we've seen publicly about this individual, her
26 specific acts that has informed your point of view?
- 27 24. **Vice President Vance:** Well, first of all, the Department of Justice is going to
28 investigate this. The Department of Homeland Security is already investigating
29 this, but the simple fact is what you see is what you get.
- 30 25. **Vice President Vance:** In this case, you have a woman who is trying to obstruct a
31 legitimate law enforcement operation. Nobody debates that. You have a woman
32 who aimed her car at a law enforcement officer and pressed on the accelerator.
33 Nobody debates that. I can believe that her death is a tragedy while also
34 recognizing that it's a tragedy of her own making and a tragedy of the far left who
35 has marshaled an entire movement.
- 36 26. **Vice President Vance:** A lunatic fringe against our law enforcement officers. Uh,
37 I, I think what, what is clearly happening here, and it's gonna keep on happening
38 unless the Democrats wake up and say, you know what? You don't have to agree
39 with our immigration policies. You don't have to agree with what the president or
40 the vice president believe about immigration enforcement.
- 41 27. **Vice President Vance:** But why don't you take this to the ballot box? Why don't
42 you vote? Why don't you organize instead, what some of them are doing? What

1 some of them are doing is encouraging people to get violent with our law
2 enforcement officials. It's disgraceful and it's gotta stop.

3 28. **Reporter:** Just to follow up on that question, and again, thank you for taking
4 questions, Mr. Vice President, there's clearly a lot of emotion in Minnesota across
5 the country over this incident. You're calling Rene Goode, a deranged leftist.
6 There's been heated rhetoric that we've also heard from officials. What
7 responsibility do you and the president have to diffuse some of the tension that we
8 are seeing play out in Minnesota?

9 29. **Reporter:** [continued] Bring down the temperature. As this investigation is
10 unfolding, what we have a responsibility to do is to protect the people who are
11 enforcing the law and protect the country writ large. Whether you're a Democrat or
12 Republican, you deserve to have the people's laws enforced in the United States of
13 America.

14 30. **Vice President Vance:** Now, again, I I don't want, I, I'm not happy that this
15 woman lost her life. I'm not happy that this woman was there at a protest violating
16 the law. By interfering with a law enforcement action, I think that we can all
17 recognize that the best way to turn down the temperature is to tell people to take
18 their concerns about immigration policy to the ballot box, stop assaulting and stop
19 inciting violence against our law enforcement officers.

20 31. **Vice President Vance:** That's the best way to take down the temperature, and
21 we're not. Look, we are not gonna give in to terrorism on this, and that's exactly
22 what's happening. People trying to antagonize to commit acts of violence. They
23 throw bricks at 'em. Sometimes they shoot at 'em, sometimes they dox them.
24 Sometimes they go to their place of residence and harass their families.

25 32. **Vice President Vance:** This is classic terrorism and we cannot say that when,
26 when, when a far left fringe is inciting violence against our brave law enforcement
27 officials that we're no longer gonna enforce the law. That's rewarding the very
28 people who are engaged in this garbage. The actual reward that they just got is a
29 new assistant attorney general who is gonna prosecute and investigate this stuff
30 even more.

31 33. **Vice President Vance:** And even more aggressively than before.

32 34. **Reporter:** Thanks for taking my question. Um, so the head of Minnesota's
33 Investigations agency says that the US Attorney's Office has essentially cut off the
34 State Investigations agency's access to the investigation. What is the precedent for
35 that and why shouldn't the Minnesota officials on the ground have access and
36 evidence to work on this investigation?

37 35. **Vice President Vance:** First of all, I wish the state officials in Minnesota would
38 investigate why you have so many people who are using their vehicles and other
39 means to actually interfere with a legitimate law enforcement operation. The
40 precedent here is very simple. You have a federal law enforcement official
41 engaging in federal law enforcement action.

42 36. **Vice President Vance:** That's a federal issue. That guy is protected by absolute
43 immunity. He was doing his job. The idea that Tim Walz and a bunch of radicals in

Minneapolis are gonna go after and make this guy's life miserable because he was doing the job that he was asked to do. Is preposterous. The unprecedented thing is the idea that a local official can actually prosecute a federal official with absolute immunity.

37. **Vice President Vance:** I've never seen anything like that. It would get tossed out by a judge. So what I'd like Minnesota to focus on is the real issue that they're encouraging people. Minneapolis officials are encouraging people to commit violence against ice officials. It's ridiculous. It's gotta stop.

38. **Reporter:** Sir, Mr. Vice President. Thank you. Uh, you said earlier that there's a left wing network to attack, to dox, to assault and make it impossible for ICE officers to do their job. Uh, you told, uh, my colleague just now that there's an investigation going on into that, into that network.

39. **Vice President Vance:** Yep.

40. **Reporter:** So if everything that you say is true, how does being part of that network justify being shot?

41. **Vice President Vance:** Well, being part of the network doesn't justify being shot, but ramming an ICE officer with your car, that's what justifies being shot. It's not a good thing, by the way, but when you force somebody to engage in self-defense. It's almost a preposterous question. I'm not saying that funding, some of this stuff justifies capital punishment.

42. **Vice President Vance:** Nobody would suggest that the reason this woman is dead is because she tried to ram somebody with her car and that guy acted in self-defense. That is why she lost her life, and that is the tragedy. Now, there may be other violations of the law and other penalties that as that, that, that, that, that, that are associated with those violations of the law, for example.

43. **Vice President Vance:** If you are funding violence against our law enforcement officers, I, I'm, I'm not a prosecutor, my guess is that's not the sort of thing that earns capital punishment, but it should sure as hell earn you a few years in prison if you're funding the effort to try to assault our, our law enforcement officers.

44. **Vice President Vance:** What, what is, I'm sorry guys. What's going on here? You guys are meant to report the truth. How have you let yourself become agents of propaganda of a radical fringe that's making it harder for us to enforce our laws? You just asked me a question that presumed that the reason why this woman died is because she was engaged in legitimate protest.

45. **Vice President Vance:** She tried to run somebody over with her car and the guy defended himself when that happened. Next question.

46. **Reporter:** The investigation is—

47. **Vice President Vance:** [interrupts] I said, next question.

48. **Reporter:** Mr. Vice President. I mean, you presumably watched the video yourself. There's not the slightest doubt in your mind having viewed it that, uh, this,

1 the victim, you still believe that she deliberately tried to ram him despite, despite
2 seeing this video?

3 49. **Vice President Vance:** Look, I don't know what is in a person's heart or in a
4 person's head, and obviously we're not gonna get the, the chance to ask this woman
5 what was going on. What I am certain of is that she violated the law. What I'm
6 certain of is that that officer had every reason to think that he was under very
7 serious threat for injury or, or in fact his life.

8 50. **Vice President Vance:** Uh, what I'm certain of is that she accelerated in a way
9 where she ran into the guy. I don't know what was in her heart and what was in her
10 head. But I know that she violated the law, and I know that officer was acting in
11 self-defense that that's a raise, an interesting point though. Look, if people wanna
12 say that we should have a, a legitimate debate about, you know, what, what was she
13 really doing?

14 51. **Vice President Vance:** Right? Was she panicking when she drove into this
15 officer, or was she actually trying to ram him? That's a, that's a reasonable
16 conversation. What's not reasonable is for so many of you to plaster all over the
17 media that this was an innocent woman and that the ice agent committed murder,
18 which is what many of you have said explicitly, and some of you have said
19 implicitly.

20 52. **Vice President Vance:** That's what I have an objection to. The idea that this was
21 not justified that. Is absurd. And I think everybody knows it in their heart.

22 53. **Reporter:** Yeah. In the green jacket, taking down the temperature, it seems like
23 political violence is ratcheting up and riots could be around the corner. What steps
24 does the administration have planned to try to unite America?

25 54. **Reporter:** [continued] Average people on both political sides are so tired of
26 fighting with, with each other, and I think all the journalists in this room could
27 agree with me, uh, that we don't wanna be part of the problem. Um, do you have
28 any words to unite America?

29 55. **Vice President Vance:** You know, I, I know you don't wanna be part of the
30 problem, and I think that's true of a lot of you. I'm not sure it's true for everybody
31 because the reporting over this has been one of the biggest scandals I've ever seen
32 in media. I've never seen a case so misrepresented and misreported when you have
33 a guy who was defending himself and is now being treated as some sort of federal
34 assassin. By so many of the people in this room.

35 56. **Vice President Vance:** What, what I, first of all lemme say about, about crime,
36 you mentioned violence. One of the things we're proudest about is that you saw
37 violent crime over the last year drop by 20%. Why is that dropped by 20%? Is it
38 because we're attacking our law enforcement officers or is it because we in the
39 administration, are empowering our law enforcement officers to enforce the law. I
40 think that's one of the ways you take down the temperature is you make people feel
41 more secure and safe in their person and property. That's why we care so much
42 about protecting our law enforcement because it, it, it, it accrues to the benefit of
43 the entire national community.

1 **57. Vice President Vance:** I think that we can absolutely talk about the ways in
 2 which, you know, we, we, we can, we can try to, we can lower the temperature. By
 3 discussing differences in a reasonable and rational way. Again, I'm happy to talk
 4 with any congressional Democrat or any of you about our immigration policy about
 5 why I think it's necessary, about why I think it's in the best interest of the country,
 6 about why the president of the United States was elected to actually enforce the
 7 border for the first time in at least four years.

8 **58. Vice President Vance:** So here's the problem. That's not the debate so many
 9 people are having. They are actively covering for people who are committing acts
 10 of violence against federal law enforcement, it is preposterous. The way to take
 11 down the temperature is to stop it. Have your debates about policy attack me.
 12 Attack the president of the United States don't attack our law enforcement officers.

13 **59. Vice President Vance:** They are trying to do the job. The American people
 14 demanded that they do. They, that they are not policy actors. They are enforcing the
 15 law. They should be treated with a modicum of dignity and respect. And the fact
 16 that they're not is why incidents like yesterday happened. The one final point I'll
 17 make about this is, look there, there's a part of me that feels very, very sad for this
 18 woman. Not just because she lost her life, but because I think she's a victim of left-
 19 wing ideology. What young mother shows up and decides they're gonna throw their
 20 car in front of ice officers who are enforcing legitimate law. You've gotta be a little
 21 brainwashed to get to that point to where you're willing not not just to protest, that's
 22 fine.

23 **60. Vice President Vance:** Not peacefully protest, but throw your vehicle. In front of
 24 legitimate law enforcement officers and drive your car into them. To get to that
 25 point, you have to be, I think, radicalized in a very, very sad way. I certainly wish
 26 that she hadn't got there. I know there's an ICE officer right now who very much
 27 wishes he was not put in the position where he had to fire a gun to to defend his
 28 own life.

29 **61. Reporter:** Yeah. Thank you Mr. Vice President, what's your message? Following
 30 up on that, what's your message to the leaders in Minnesota, the governor of
 31 Minnesota, the mayor of Minneapolis, to calm down the situation on the ground, on
 32 the streets? What's your message also to those protestors who saw that video in a
 33 completely different way than you saw that video?

34 **62. Vice President Vance:** Well, first of all, I, I think if you watch every angle of that
 35 video, um, there, there is one angle where if you squint, you can maybe tell
 36 yourself that it's not clear what happened, but when you look at all angles of that
 37 video, it is very clear that her vehicle went right for the guy. She actually collided
 38 with him.

39 **63. Vice President Vance:** And then that's of course when he fired his shots. That's
 40 obvious. Okay. So what I'd say to the protestors is, by all means protest peacefully,
 41 but make this about ideas. Make this about disagreement with our policy. Don't use
 42 your protest as a justification or an encouragement for people to go and, and, and
 43 incite violence and participate in violence against our law enforcement officials, to
 44 the people on the ground in Minneapolis, meaning that the local officials in

1 Minneapolis from Tim Walz on down, I, I'd say, look, why can't you just disagree
2 with a given piece of immigration policy without turning law enforcement into the
3 enemy?

4 **64. Vice President Vance:** And what I mean, think about, for example, a criminal law
5 where a police officer goes and arrests somebody because they violated a criminal
6 law. If you're mad about that, go and protest the politician who passed that law
7 don't attack the police officer who's just doing their job. We had a wide open border
8 under Joe Biden.

9 **65. Vice President Vance:** I happen to think it's a good thing that President of the
10 United States has closed it down. If you think that's a bad idea, criticize this
11 administration for a policy decision. Don't attack our people for enforcing the law
12 because I guarantee you go to ice. There are black people and white people. There
13 are Democrats and Republicans.

14 **66. Vice President Vance:** They are patriotic Americans who are trying to enforce the
15 law. Attack me. Lay off of our ice agents.

16 **67. Reporter:** Vice president. Yeah. In the blue all the way. Yeah. Thank you. Mr.
17 Vice President, um, you called on Tim Walz to resign. Can you lay out the case as
18 to why he should step down?

19 **68. Vice President Vance:** Well, I look, I think Tim Walz should resign because it's
20 very clear either that he knew about the fraud of Minneapolis, he knew about the
21 welfare fraud, or at the very least, he looked the other way. I mean, this is not. This
22 is not like Lex Luthor, right? This is not movie villain fraud. This is the lowest IQ
23 possible fraud. This is, we're gonna take kids, or sorry, we're gonna take the
24 absence of kids and set up a daycare center. Where there are no children, and we're
25 gonna call our early childhood Education center, the Quality Leering Center.

26 **69. Vice President Vance:** By the way, if you can't spell learning, maybe you
27 shouldn't be in early childhood education, but people got rich off of this. We know
28 that there were schools who either had no enrollment. Or at least they overstated
29 their enrollment. Tim Waltz either was unbelievably incompetent or he was in on
30 the fraud.

31 **70. Vice President Vance:** That's one of the things we're gonna get to the bottom of.

32 **71. Reporter:** Sir. Thank you. Mr. Vice President. Can you explain the difference
33 between this Associate Attorney general and a special counsel, and do you envision
34 this being a permanent position or having more of a limited scope?

35 **72. Vice President Vance:** Well, it's gonna be permanent until we get to the bottom of
36 what's going on, so I think it's gonna last for at least the remainder of the
37 administration. What's different about it from a special counsel is if you remember,
38 uh, the Jack Smith case where the special counsel was found unconstitutional. One
39 of the big issues there is that that person was not an appointed person, uh,
40 completely aside from all the other issues, that the person was a lunatic and that the
41 case had no merit.

1 **73. Vice President Vance:** There was a fundamental constitutional issue, which is
 2 that he had not been appointed by the president and he had not been confirmed by
 3 the United States Senate, an assistant, or, excuse me, an Assistant Attorney
 4 General. What that's gonna allow us to do is appoint this person, have them
 5 confirmed by the Senate.

6 **74. Vice President Vance:** That's one difference. The more substantive difference is
 7 that this person is gonna be part of a very broad, interagency White House that's
 8 being led from the President of the United States on down, and that's gonna give
 9 'em the resources, the access to material and information to make this person more
 10 effective.

11 **75. Vice President Vance:** I think a lot of people have asked, how are you really
 12 gonna get to the heart of the fraud? We've been asking ourself that question for the
 13 past couple of months, and we think this is the critical piece at the Department of
 14 Justice to to, to really ramp this fraud investigation into high gear.

15 **76. Reporter:** In the red tie. Yeah. Vice President Vance, I want to ask, what's your
 16 message to far left as the agitators who feel emboldened to obstruct ice activity in
 17 Minnesota and around the country?

18 **77. Vice President Vance:** Well, I think they shouldn't feel emboldened because now
 19 they have an assistant attorney general who is gonna prosecute and investigate their
 20 fraud and their violence more aggressively than it has ever been investigated in the
 21 United States of America.

22 **78. Vice President Vance:** We are doing so much to try to find the financing
 23 networks and the domestic terrorism networks that legitimate this violence, that
 24 fund this violence, and that, of course, engage in the violence. These people should
 25 not feel emboldened because they have for the first time, maybe in American
 26 history. An administration that is not gonna tolerate political violence of any kind
 27 from anywhere.

28 **79. Reporter:** We're not clear today that the entire weight of the federal government is
 29 behind these ICE agents, and this ICE agent in particular, there is still a federal
 30 investigation happening on the ground. Does that mean that they are not looking
 31 into this ICE agent at all? They are just focused on the woman who was in the car?

32 **80. Reporter:** [continued] What, what is the investigation if the federal government
 33 has already determined that its weight is behind this ice investigation?

34 **81. Vice President Vance:** So, so what do you mean? When you say investigation, do
 35 you mean investigation of the shooting yesterday or of the fraud that's happening in
 36 Minneapolis?

37 **82. Reporter:** Yesterday.

38 **83. Vice President Vance:** Okay. Look, DHS, as I understand it, has an investigation
 39 already ongoing. I know that other organs of our government are looking at this, so
 40 yes, there's certainly an investigation that's happening right now. Uh, but, but as
 41 part of the broader fraud investigation, a lot of what we're doing with the
 42 Department of Justice has already started. We've got over 1500 subpoenas. We've

1 got people this morning actually we're going door to door to actually knock on
2 some of these fraudulent care centers, these fraudulent social services organizations
3 to get to the bottom of what's going on there.

4 **84. Vice President Vance:** So the investigation, in some ways has already been
5 ramping up into the anti-fraud element for at least a few weeks. What we're trying
6 to do is supercharge it and make sure there's a designated person within the
7 Department of Justice who completely controls that particular focus.

8 **85. Reporter:** Just to follow up on that, Mr. Vice President, uh, on the agent, is he still
9 on duty or has he been placed on leave, uh, on administrative leave, and what really
10 was the target of the operation on Wednesday? ICE operation on Wednesday?

11 **86. Vice President Vance:** Well, first of all, it was a legitimate law enforcement
12 operation. We were going door to door to try to find criminal illegal aliens and
13 deport them from the United States of America.

14 **87. Vice President Vance:** Because if you come to our country illegally in violation
15 of our immigration laws, then we have the mandate, and in fact, we have the legal
16 duty to enforce those immigration laws. Whether he's been placed on
17 administrative leave, I don't know the answer to that question. I'd refer to the
18 Department of Homeland Security and they can follow up.

19 **88. Vice President Vance:** I will say, look, I, I would appreciate everybody saying a
20 prayer for that, that agent. Look, in the past six months. He has been hit twice by a
21 motor vehicle one time, the first time it led to over 30 stitches and very serious
22 injuries to his legs. This is a guy who's actually done a very, very important job for
23 the United States of America.

24 **89. Vice President Vance:** He's been assaulted, he's been attacked, he's been injured.
25 Because of it. He deserves a debt of gratitude. And I think the media prejudging
26 and talking about this guy as if he's a murderer is one of the most disgraceful things
27 I've ever seen from the American media.

28 **90. Reporter:** Vice President. What is your specific role in the future of Venezuela?
29 And I'm wondering, could you confirm reports that the Director of National
30 Intelligence, Tulsi Gabbard, was kept out of the planning for the operations because
31 of her past concerns about military involvement in Venezuela?

32 **91. Vice President Vance:** So I've heard a couple of things, one that I was kept outta
33 the planning for the Venezuela operation. That's false. And another, that Tulsi was
34 kept out of the planning for Venezuela operations. That's completely false. Look,
35 we're all part of the same team and one of the things that is really amazing about
36 that operation is that, uh, we kept it very tight to the senior cabinet level officials
37 and related officials in our government.

38 **92. Vice President Vance:** And we kept this operation secret for a very long time. I'm
39 very proud of that. I think it suggests, I think it suggests that the team works very
40 well together. What, looking ahead, what does my role look? My role is gonna be
41 whatever the president asks me to do.

42 **93. Reporter:** Has he asked something?

1 94. **Vice President Vance:** Well, every single, or I should say, every other day, I'm
 2 chairing the meeting that we do on this among White House principals to talk about
 3 next steps to try to ensure that Venezuela is stable and as the President has directed
 4 us to do, to ensure that the new Venezuelan government actually listens to the
 5 United States and does what the United States needs it to do, uh, under our
 6 country's best interest. So I'm gonna be as involved as the president wants me to be.
 7 So far that's been very involved and I'll keep on doing that so long as the president
 8 asked me to do it.

9 95. **Vice President Vance:** Even, even the powers, we'll go purple and then we'll go
 10 pink or whatever that is in front.

11 96. **Reporter:** Royal purple and beige. Alright. Okay. Are there any indications, you
 12 talked about the network, are there any indications that the, uh, the lady who was
 13 shot, I know there are different reports. From there, her, her wife said they were
 14 new to the area. Um, are there any indications she may have been a paid agitator
 15 and maybe that there are others that were brought to the area, um, concerning
 16 everything that's going on in Minneapolis?

17 97. **Vice President Vance:** I wouldn't say that she was paid. I don't have the evidence
 18 to say that one way or the other. What I do know is that she was violating the law,
 19 and if you just look at the eyewitness accounts, they were saying she was there to
 20 prevent the enforcement of the law. She was trying to obstruct a legitimate law
 21 enforcement operation.

22 98. **Vice President Vance:** That much is obviously clear. The rest of it, of course, is
 23 part of the reason why we investigate this stuff.

24 99. **Reporter:** Yeah. Mr. Vice President, even beyond the war powers resolution
 25 today, Congress has bucked President Trump on issues like tariffs. Are you
 26 concerned that President Trump is losing his grip on Republicans and the Congress
 27 and what are you gonna do about it?

28 100. **Vice President Vance:** No, I'm not concerned at all. First of all, you know, we,
 29 we talked to some of the Senators who are gonna vote the wrong way, in my view
 30 on this resolution today, much of their argument was based more on a legal
 31 technicality than any disagreement in policy. If you look at the people who actually
 32 voted, every single one of them have supported the administration's plan.

33 101. **Vice President Vance:** Second of all, as the president, I believe himself has
 34 already said, every President, Democrat, or Republican believes the war powers act
 35 is fundamentally a fake and unconstitutional law. It's not gonna change anything.
 36 About how we conduct foreign policy over the next couple of weeks, the next
 37 couple of months. Uh, and that that'll continue to be how we approach things.

38 102. **Reporter:** Go ahead. So much vice president. So we are seeing regarding Iran,
 39 we're seeing the protests in Iran these days. The cities are, are begging for help
 40 from the US and Israel naming streets in the city after President Trump. It seems
 41 there is an opportunity here that may not come again. Will the United States stand
 42 by the citizens of Iran and if Israel decides to strike again the nuclear sites in Iran,
 43 is the US expected to take part?

1 103. **Vice President Vance:** Well, look, we, we certainly stand by anybody who's
 2 engaged in peaceful protests, anybody who's trying to exert their rights for free
 3 association and to have their voices heard. Obviously, the Iranian regime has a lot
 4 of problems, and as the president of the United States has said, the smartest thing
 5 for them to have done it was true two months ago. It's true today is for them to
 6 actually have a real negotiation with the United States about what we need to see
 7 when it comes to their nuclear program.

8 104. **Vice President Vance:** I'll let the president speak to what we're gonna do in the
 9 future, but we certainly stand with anybody across the world, including the Iranian
 10 people who are advocating for their rights.

11 105. **Vice President Vance:** I'll take just a couple more questions.

12 106. **Reporter:** Thank you very much Mr. Vice President, uh, concerning Venezuela.
 13 How would you assure the Caribbean region that they will remain a zone of peace?
 14 Because some member states in the region are concerned?

15 107. **Vice President Vance:** Well, look, the president had a, a very productive phone
 16 call with the President of Columbia yesterday, and we continue to talk at all levels
 17 of government with a number of our friends in the Caribbean region. I actually
 18 think this is really good for peace in the Caribbean because when you take away a
 19 major source of illegal cartel revenue, which is the cocaine trade, the fentanyl trade,
 20 other sources of illicit revenue.

21 108. **Vice President Vance:** If you actually remove the power of one of the main
 22 destabilizing forces in Latin America and in the Caribbean, I really do think, look,
 23 we, we say it all the time. This is the president of peace. One of the ways that you
 24 establish peace in your own hemisphere is to make it clear that the United States is
 25 gonna be respected, that the United States is willing to take power away from
 26 criminal cartel organizations and give it to legitimate governments. That's how we
 27 see the future of the Western Hemisphere, and we think it's gonna be much more
 28 peaceful than it was certainly under Joe Biden.

29 109. **Vice President Vance:** I'll take one more question.

30 110. **Reporter:** Go ahead. Thank you. On Greenland, do you have a message for
 31 European leaders? Many in Europe reject the idea that the island could be for sale.

32 111. **Vice President Vance:** Well, first of all, Secretary Rubio, I believe, is meeting,
 33 uh, with the leaders of Denmark and Greenland next week. I wanna say it is, but
 34 maybe it's the week after that. Uh, we'll, we'll, we'll continue to deliver some of
 35 these messages in private, some of them in public. But I, I guess my advice to
 36 European leaders and anybody else would be to take the president of the United
 37 States seriously.

38 112. **Vice President Vance:** What has he said about Greenland? Set, set to the side,
 39 the crazy overreactions that I've seen from the press and from certain people in
 40 Europe? What has the president said, number one? Greenland is really important,
 41 not just to America's missile defense, but to the world's missile defense. Number
 42 two, we know that there are hostile adversaries that have shown a lot of interest in
 43 that particular territory, that particular slice of the world.

1 113. **Vice President Vance:** So what we're asking our European friends to do is to
 2 take the security of that landmass more seriously, because if they're not, the United
 3 States is gonna have to do something about it. What that is, I'll leave that to the
 4 president, uh, as we continue to engage in diplomacy with our European friends
 5 and everybody on this particular topic.

6 114. **Vice President Vance:** And again, thank you all for, for listening. Thanks for
 7 taking questions. And I just ask you look. Okay, this is politics and often
 8 Republicans and you know, get, get in, get in arguments with the press about
 9 things. I understand that. I think it's really irresponsible for you guys to go out there
 10 and imply or tell the American people that a guy who defended himself from being
 11 rammed by an automobile is guilty of murder.

12 115. **Vice President Vance:** Be a little bit more careful. We're gonna talk about toning
 13 down the temperature, which I know the president wants to do and I certainly
 14 wanna do. One of the ways we tone down the temperature is to have a media that
 15 tells the truth. I encourage you all to do that. God bless you.

16 116. **Reporter:** President. Happy New Year guys.

21 22 **Evidentiary Significance**

23 This transcript documents Vice President JD Vance's public press conference held one
 24 day after the shooting death of Rene Good by an ICE officer in Minneapolis. The
 25 statement is significant for several reasons:

- 26 1. **Pre-Investigation Adjudication:** Vance publicly declared the ICE officer acted in
 27 "self-defense" and characterized the shooting as "justified" (§§24-25, 41, 52) before
 28 any investigation was completed, while simultaneously acknowledging
 29 investigations were ongoing (§§24, 83).
- 30 2. **Characterization of Victim:** Vance repeatedly characterized the deceased as a
 31 "deranged leftist" (§§23, 28), part of a "broader left wing network" (§§4, 19-22),
 32 and victim of "left-wing ideology" (§§59) based solely on her presence at the scene.
- 33 3. **Absolute Immunity Claim:** Vance asserted the ICE officer "is protected by
 34 absolute immunity" (§36), which is a legal conclusion that would typically be
 35 determined by courts, not the executive branch.
- 36 4. **Domestic Terror Framing:** Vance characterized peaceful protest activity as
 37 "classic terrorism" (§32) and "domestic terror techniques" (§5), potentially
 38 criminalizing First Amendment protected activity.

1 5. **Media Intimidation:** Vance accused reporters of being "agents of propaganda"
2 (¶44) and suggested they "should be ashamed" (¶7) for reporting on the incident,
3 constituting potential chilling of press freedom.

EXHIBIT N-9: FBI Director Patel Congressional Epstein Testimony

1. **FBI Director Patel:** Now, I know that there's a lot of talk about Epstein, and I'm here to testify that the original sin in the Epstein case was the way it was initially brought by Mr. Acosta back in 2006. The original case involved a very limited search warrant or set of search warrants and didn't take as much investigatory material it should have seized. If I were the FBI director, then it wouldn't have happened. The search warrants were limited to small time periods to include 2002 to 2005 and 1997 to 2001. Mr. Acosta allowed Epstein to enter in 2008 to a plea and nonprosecution agreement which then the courts issued mandates and protective orders legally prohibiting anyone from ever seeing that material ever again without the permission of the court. The non-prosecution agreements also barred future prosecutions for those involved at that time of those individuals.
2. **FBI Director Patel:** Still, this administration, at the direction of President Trump, has done more to turn over all the credible information we are legally able to do so, and we will continue to work with Congress to achieve that end. Under the direction of the president, we excuse me, thank you for your support for our mission to working to jointly deliver transparency and congressional oversight to the United States.
3. **FBI Director Patel:** Lastly, I want to close with the president's initiative here in Washington DC as an example of what we're doing around the country. And I think our next city is Memphis. 21,000 arrests in DC with our federal partners. A huge decrease in violent crime. 60% decrease in gun crimes in Washington DC in the last month. 74% decrease in carjackings in Washington DC in the last month. 53% decrease in homicides in Washington DC in the last month. The drugs are disappearing. People are freely walking around the states and restoring the nation's capital to its glory.
4. **FBI Director Patel:** That work is through the inter agency process that the FBI is proud to be a part of and the initiative spearheaded by President Trump and the attorney general. And perhaps most notably for investigations in Washington itself, it was the intelligence that the FBI gathered through our source network here in DC that helped us identify the suspects in the horrific murder of the DC intern Eric Tarpinian. We're proud to be a part of that investigation. We're proud to put the resources to bear of the FBI. And in closing, Mr. Chairman and members of the committee and ranking member Durban, I'm honored to be the ninth director of the FBI. I'm not going anywhere. If you want to criticize my 16 years of service, please bring it on. Over to you.
5. **Chairman Grassley:** U I've observed uh when whether it's Republican or Democrats want a yes or no answer that the witness and the senators talking over each other. So, I thought what I'd do this time rather than have that happen, if there's something you don't get a chance to answer uh because of the demeanor of a Republican or Democrat senator before we when we get done with that uh questioner, I'd give you a chance to fill in if there's something you didn't get a chance to say.

1 6. **Chairman Grassley:** Uh since 2019, I've sought greater transparency about Jeffrey
2 Epstein and the government handling of the matter. I've continued to investigate
3 during this Congress.

4 7. **Chairman Grassley:** Director Patel, was Jeffrey Epstein an intelligence asset for
5 the United States government or the foreign government? And if so, which
6 agencies or governments?

7 8. **FBI Director Patel:** Mr. Chairman, I can only speak to the FBI as the director of
8 the FBI and Mr. Epstein was not a source for the FBI.

9 9. **Chairman Grassley:** Uh would you commit to providing my office with all
10 classified non-classified records relating to the Epstein matter?

11 10. **FBI Director Patel:** I will commit to providing all records I'm legally permitted to
12 do so under the court orders.

13 11. **Chairman Grassley:** Uh uh it seems to me that uh I accept your answer to my
14 question, but the broader intelligence community ought to answer these questions
15 as well. Uh victims deserve an answer.
