MINUTE ORDER. Upon considering the [42] and [48] Stipulations and Plaintiff's [49] Response to the [45] Notice, the Court ORDERS that Plaintiff shall file his Third Amended Complaint, if any, on or before April 29, 2026.

Accordingly, all Defendants' deadline to answer or otherwise respond to the Second Amended Complaint, Dkt. [13], is hereby STAYED pending the filing of Plaintiff's anticipated Third Amended Complaint.

The Court further ORDERS that, once Plaintiff files the Third Amended Complaint, the parties shall promptly contact the Courtroom Deputy, Chashawn White (chashawn_white@dcd.uscourts.gov), to schedule a status hearing to discuss the case before any responsive pleadings are due.

Finally, because the Court understands that Plaintiff intends to file a Third Amended Complaint, see Dkt. [42], [48], [49], the Court DENIES AS MOOT Plaintiff's [8] Motion for leave to File Exhibits Under Seal; [14] Motion for TRO and Preliminary Injunction; and [15] Emergency Motion for Discovery and Immediate Preservation Order.
